Mowing of Seeded Roads Near Little Girls Point

Solicitation: Maintenance and rejuvenation of previously seeded logging roads to promote high-quality food areas for deer through mowing designated areas of Gogebic County, Michigan is issued as a competitive full and open acquisition which will result in the award of a one-time contract.

- A. General Liability insurance for the project written on an occurrence form with policy limits of not less than One Million dollars (\$1,000,000).

- D. Capacity to complete project in required timeline.
- E. Completeness of proposal. Each proposal will be considered independently.

In 2018 and 2019, several closed logging roads were prepped and seeded with clover. To promote the future growth of clover and discourage other vegetation, these converted road segments will be mowed. A total of seven road segments will be mowed for a total 3.32 miles, or 6.04 acres of surface. Each road is roughly ten-foot wide. Sites are scattered across several miles and will require trailering of equipment between sites. Please refer to attached Map 1 for exact locations, distance apart, and relative size of each road segment.

Locations are as follows:

County: Gogebic Township: 48N-49N Range: 47W-49W

Section: 6, 9, 10, 11, 16 and 19 of T48N, R48W

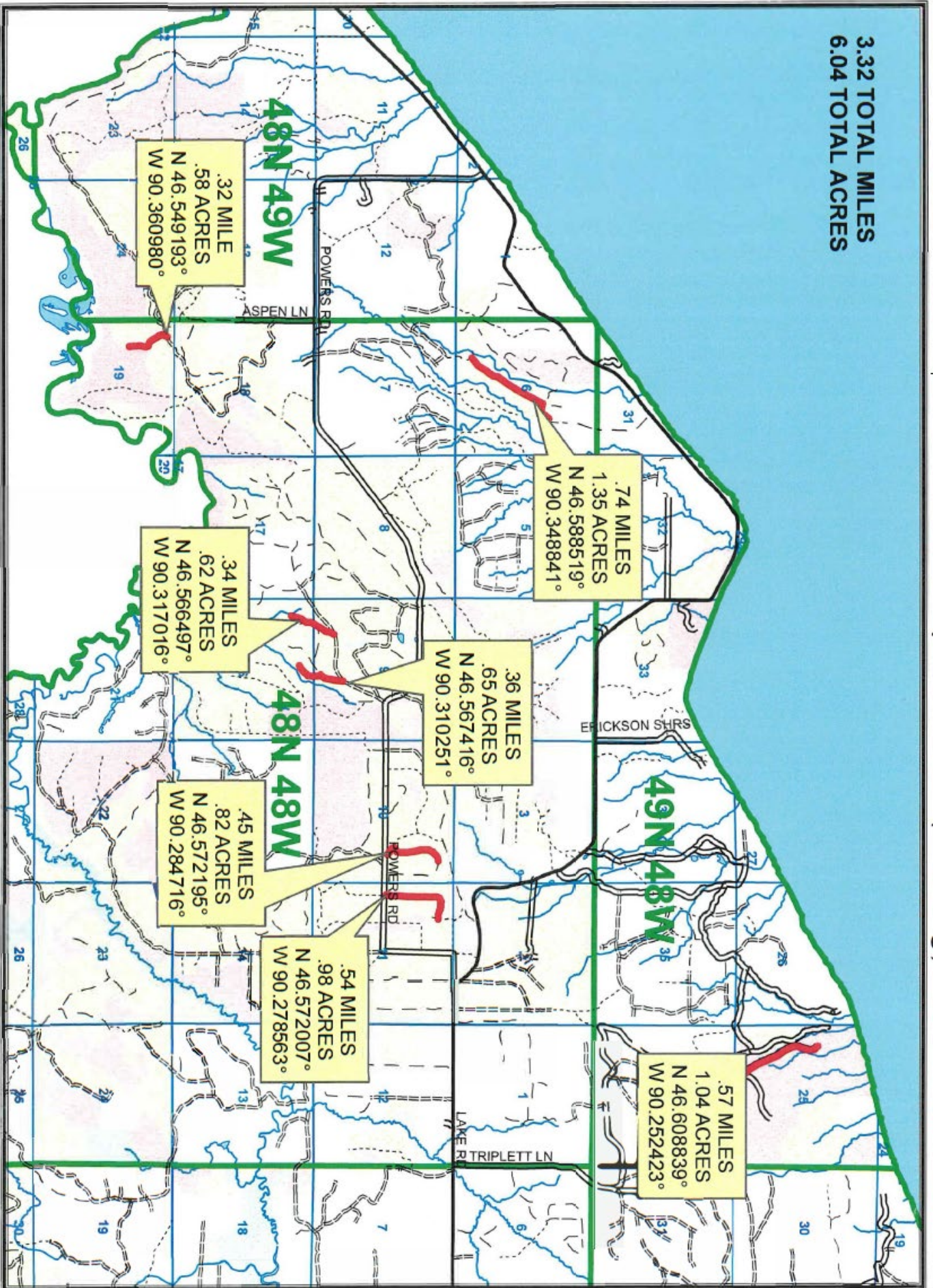
Section 25 of T49N, R48W

Work shall be completed between August 2, 2021 to September 17, 2021. Upon award, a pre-work conference shall be scheduled to discuss a suitable timeline for project completion and communication. On-site management and direction of this project will be conducted by Gogebic County Forestry and Parks Staff. Equipment used should be adequate for mowing on uneven surfaces and handling some woody vegetation; low-impact equipment is preferred. All equipment proposed to be used for this project must be listed on the **Proposal worksheet.**
